



# APPLICANT INFORMATION

NARHC BOARD OF DIRECTORS

January 2023 – December 2025

Board members serve 3-Year Terms. They are voted into office by the members at the Annual Meeting (Oct. 25, 2022) held during the NARHC Fall Institute in Scottsdale Arizona. Absentee ballots are also accepted in advance of the Annual Meeting. Candidates are given 5 minutes to introduce themselves there. Attendance is encouraged but not required.

**REQUIREMENTS:** Candidates must be employed by a current NARHC member & maintain NARHC membership once elected. The ideal candidate will have leadership ability and extensive Rural Health Clinic knowledge. We want to especially encourage Providers and others who work directly in and with the Rural Health Clinic(s) to apply. The ideal candidate will assist in growing the NARHC Association Membership by being an advocate and cultivating a relationship with his or her State Association & others. We prefer candidates from states not already represented on the Board but this should not prohibit one from running. States currently represented: AL, IL, FL, IL, LA, MS, MT, PA, SC, TX, 2 from MI, and 1 from MO.

**TIME COMMITMENT:** Board members are expected to attend the 2 NARHC conferences (2 ½-3 days long in March & October) and be present on 1-hr./mo. conference calls (3rd Wed. of the Month at 2:30 p.m. Eastern time). Additionally, members should plan to serve on the occasional subcommittee. Time commitment varies but is approximately 2-7 hours/month. NARHC is occasionally called upon to provide a speaker at State Conferences. Board Members, who are comfortable speaking, may be asked to represent NARHC. Your expenses will be fully covered for outside speaking engagements. Board members though pay their own airfare & expenses to the 2 NARHC conferences. NARHC pays for your conference registration and lodging fees (if desired).

There are 3-4 seats open every year (4 this year). We do have term limits. Individuals elected to the Board shall be limited to 3 consecutive 3-year terms. Board Members may be eligible for re-election to the Board after a 2-year absence from the Board. A Nominating Committee reviews the qualifications & experience of individuals seeking election to the Board of Directors and makes a recommendation to the members of a slate of candidates for election. Failure of the Nominating Committee to recommend an individual for election shall not prevent that individual from being a candidate.
